Subject: Intimation of fire accident at one of our manufacturing unit situated at Plot No. 5511, 5512 and 5513, Mouza - New Kolorah, Police Station - Domjur, District - Howrah, West Bengal – 711302

Pursuant to Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 read with Schedule III thereof and SEBI Circular No. CIR/CFD/CMD/4/2015 dated September 9, 2015, we write to inform you that a fire accident took place today i.e. 3rd November, 2021 at one of our manufacturing unit situated at Plot No. 5511, 5512 and 5513, Mouza - New Kolorah, Police Station - Domjur, District - Howrah, West Bengal – 711302 (“Kolkata unit”). However, there is no casualty.

The fire resulted in damage to inventories, plant and machineries and building, thereby disrupting the operations of the Kolkata unit. Till the time, the operations resume in the Kolkata unit, the demand of the Eastern market will be catered from our another manufacturing unit located at Guwahati.

Further, we would like to inform you that the Company has adequate insurance coverage and have informed the Insurance Company about the incident and coordinating with them for ascertaining the loss/damage caused due to the fire.

Any further material development in this regard will be updated promptly.
