Environmentalists VS Pal and Anshu Pal trained the faculty, staff and daily wage workers to make seed balls. Welcoming the guests, principal Sonal Sisodia in her address said that in such times a new technique, which is called seed bombing will definitely help in making the city green.

The experts shared that seed bombing is actually an aerial reforestation technique. It is a technique meant to introduce vegetation by throwing seed balls on barren land. With this afforestation spending much time on it and they can also have fun on the run. They said that one needs to find an open area where one could

spread the seed bombs.

Those who really want to contribute to our environment can carry seed bombs even on long tours. While driving to different places. people come across several barren lands or river banks where they can throw these seed bombs. It can also be a part of your gardening routine. These seed bombs can be preserved for a longer time and used when your travel. However, one must consider the fact that the seeds should be native to the place. If the grass is thick one

might have to clear a small patch to find solid dirt to place the seed bomb on. The next heavy rain starts the process. Until then the clay keeps the insects, rain or wind from carrying away your seeds. A heavy rain distechnique, people can help solves the clay away without enough to get the seed to germinate and take root in the soil below, feeding meanwhile on the compost that is part of the

Over 1,300 unlicensed weapons have been seized and preventive action has been taken against more than 1.73 lakh persons ahead of the urban local bodies elections in Madhya Pradesh, an official said on Tuesday.

HC directs CBI probe into fake DNA test

High Court's principal bench, Jabalpur, has instructed the state government for CBI or STF probe in the fake DNA report in connection with the murder incident reported on May 16, 2021, according to the advocate of accused.

Two accused Sandip Thakur and Ansul Thakur were arrested. Sickle, other arms and clothes were recovered. Samples were sent for DNA test.

The Madhya Pradesh Commission for Protection of Child Rights (MPCPCR) has recommended to the Madhya Pradesh government to bring all private schools in the state, including minority educational institutions, under the Right to Education (RTE) Act. The government can make a rule to do it, he said.

The commission has written a letter to the minister for school education

Inder Singh Parmar making a recommendation to this effect. It may be mentioned here that minority educational institutions are exempted from the ambit of the RTE Act and are not mandatorily required to admit students under the RTE.

Member of the commission Brajesh Chauhan told Free Press that many leading private schools were using the stratagem of ensuring that a majority of the members in the school management committees were from the minority communities. should stop," he said. He further said that there

under the RTE are 30,000 private schools

to children of eligible families under the RTE. There are still 4,000 private schools in the state which don't come under the RTE. Out of these 4000 schools, around 2,000 schools have been closed during the Covid-19 pandemic.


