#### No role in deciding state capital: Centre tells Andhra HC

AMARAVATI: The Centre has conveyed to the Andhra Pradesh High Court once again that it has no role to play in deciding the capital city of a state. The Ministry of Home Affairs said this in a counter-affidavit filed in response to a High Court notice while hearing petitions challenging the state government's move to trifurcate the state capital. The counter-affidavit filed by MHA Under Secretary Lalita T Hedao submitted that the Andhra Pradesh Capital Region Development Authority Repeal Act, 2020, was introduced and passed by the state Assembly.

#### Covid test result now available online in Karnataka

BENGALURU: People in Karnataka who have undergone a coronavirus test can now get the result online by just entering their Specimen Referral Form (SRF) ID, an official said on Wednesday. "Now you can know your Covid test result by feeding SRF ID of your Covid test in the following portal," said a state Covid War Room official. The Karnataka Covid War Room headed by senior IAS officer Munish Moudgil has developed the portal for easier access of test

#### One more body recovered from Pettimudi, toll 62

IDUKKI: The body of an eight year-old boy was recovered from the landslide site at Pettimudi in the high range Idukki district on Wednesday, taking the toll to 62, officials said. Search for the remaining eight people, who are missing, will continue on Thursday. Two Ground Penetrating Radars (GPR)s from Chennai are also being used for search operations.

#### TN heirs of people killed in landslide will get Rs 3 lakh

CHENNAI: Heirs of each of those who died in a landslide in Kerala and living in Tamil Nadu will be provided an assistance of Rs three lakh, Chief Minister K Palaniswami announced on Wednesday. Direct successors of every person killed in the landslide and residing in Tamil Nadu would be given Rs three lakh financial aid, Palaniswami said. Those who sustained serious injuries shall get Rs one lakh, he said, adding that the assistance would be provided from the Chief Minister's Public Relief Fund. Palaniswami said the tea estate labourers killed at Munnar of Kerala were natives of Tamil

#### Flood warning in Karnataka's Krishna river basin

BENGALURU: As monsoon rains continue to lash Maharashtra and Karnataka, the Central Water Commission (CWC) on Wednesday issued flood warning to areas in the Krishna river basin across the state's northwest region. "As heavy rainfall in the catchment areas will lead to more inflow of water into the reservoirs across the Krishna river basin, flood warning has been given to the authorities in the state's border districts to prevent loss of life and damage to property," a CWC official said here. "As dams in both states across the river basin are filling up to their capacity, discharge of excess water will flood farmlands and villages in the region," said the official.

#### Hyderabad varsity gears up for entrance exams from Sept 24

**HYDERABAD:** The University of Hyderabad (UoH) on Wednesday said it would hold its nation-wide entrance examination for admission to various post-graduate and research courses between September 24 and 26. UoH Vice-Chancellor professor Appa RaoPodilesaid the university was going ahead with the schedule after the Supreme Court gave its nod to holding of JEE and NEET. Over 62,000 candidates seeking admission this year would appear for the entrance exam in 38 centres across the country (in offline mode), the Vice-Chancellor said. The university, he said, plans to complete the admission process and start classes for the new students latest by the first week of November, a press release from UoH

# 10,000 troops out of valley

40 COMPANIES OF CRPF AND 20 EACH OF CISF, BSF AND SASHASTRA SEEMA BAL WILL BE TAKEN OUT FROM JAMMU AND KASHMIR BY THIS WEEK

AGENCIES New Delhi

The Centre on Wednesday ordered "immediate" withdrawal of about 10,000 paramilitary personnel from the Union Territory of Jammu and Kashmir, officials said.

This is the biggest de-induction of these forces after additional troops were rushed to the UT post the abrogation of the Article 370 of the Constitution that gave the erstwhile state a unique status.

They said the decision was taken after the Ministry of Home Affairs reviewed the deployment of the Central Armed Police Forces (CAPFs) in the union territory (UT).

The Home Ministry had last withdrawn 10 CAPF companies from the UT in May, while 72 such units were taken out in December last year. A senior official told PTI

that a total of 100 CAPF com-



panies have been ordered to be withdrawn "immediately" on Wednesday and they have been asked to revert to their base locations in the country.

As per the directions, a total of 40 companies of the Central Reserve Police Force (CRPF) and 20 each of the Central Industrial Security Force, the Border Security

Force and the Sashastra Seema Bal, will be taken out from Jammu and Kashmir by this week.

The CRPF has been asked to make arrangements for air lifting of these units to Delhi and other locations, they said. A CAPF company has an operational strength of about 100 personnel.

"The units that are being withdrawn are deployed both in Jammu and Srinagar. It was felt that the counter-insurgency and counter-terrorist grid is intact in the UT and these additional units that were sent in last year can be de-inducted giving them the much required rest, recuperation and training," a senior CAPF officer said.

Also, he said, with the winters soon setting in, it would have been an onerous task to keep these units in makeshift and temporary dwelling units especially in the Kashmir valley region.

With the latest de-induction, the lead counter-terrorist force CRPF will have a strength of about 60 battalions (about 1,000 personnel in each battalion) in the Kashmir valley apart from very few units of the other CAPFs.

### Govt to conduct profiling of beneficiaries of PM SVANidhi scheme

The Centre has decided to conduct a complete socioeconomic profiling Prime Minister Street Vendors Atmanirbhar Nidhi (PM SVANidhi) scheme beneficiaries. The purpose is to facili-

tate their actions in other welfare government schemes like Pradhan Mantri Awas Yojana (Urban), Aayushman Bharat, Ujjawala, Jan Dhan Yojana, Saubhagya, Deendayal Antyodaya Yojana-National Urban Livelihoods Mission (DAY-NULM) and others.

PM SVANidhi has been launched to provide credit for working capital to street vendors to resume their business. The decision was taken in a meeting chaired by Union Urban Development Minister Hardeep Singh Puri.

The meeting was attended by Chief Secretaries, UD

Secretaries, Principal Secretaries, DGPs, Collectors, SPs, SSPs, Municipal Commissioners, Chief Executive Officers of 125 cities. While the scheme provides the credit facility to the vendors, there is a requirement to ensure that they are able to do business in a harassment free environment, the Minister said.

Puri launched a mobile app for ULB functionaries on the occasion. This app aims to provide user friendly digital interface for the functionaries of ULBs to source loan applications of street vendors.

The minister received feedback from states and UTs. He urged the Ministers of Urban Development and senior officials to hold meetings with key stakeholders towards successful implementation of PM SVANidhi and also to ensure the protection of livelihood of street vendors.

### AllA and Nisarga Herbs to conduct clinical trial on Covid-19 with Neem capsules

NEW DELHI: All India Institute of Ayurveda (AIIA), New Delhi has announced their collaboration with Nisarga Biotech Pvt Ltd, parent company of Nisarga Herbs to conduct a doubleblind, randomised, placebo controlled trial at ESIC Medical College and Hospital, Faridabad.

Prof (Dr) Tanuja Nesari, MD, PhD, director of AIIA, will be the principal investigator and Dr Asim Sen, Dean ESIC medical college and hospital, Faridabad will be the co-investigator along with team of 6 doctors from AIIA and ESIC. Nisarga is the first Indian Ayurveda company to work with AIIA, who will study their proprietary neem extract formulation for the prevention of Covid-19 in 250 subjects.

The study entitled 'Prophylaxis with Neem capsules in healthcare personnel and relatives in contact with Covid-19 patients' is designed primarily to evaluate the preventative effect of neem capsules in subjects coming in contact with Covid-19 patients.

### Kerala CM backtracks on CDR, tells court seeking only tower location

Thiruvananthapuram

After maintaining although that its decision to collect call detail records (CDRs) of Covid

positive patients was a correct one, the Pinarayi Vijayan-led Kerala government on Wednesday went back on it and informed the Kerala High Court that it will only collect the tower location of a Covid patient, and nothing else.

A division bench of the court was hearing a petition filed by Leader of Opposition Ramesh Chennithala demanding the in-

tervention of the court to prevent the new directive from being implemented, terming it as gross violation of people's privacy. The state government

> pointed out that it's only intention is to ensure that those under quarantine not break the rules, and the process of contact tracing is made easier using CDRs of the infected persons.

The court, however, asked the state government to come back with all the modalities of what they actually plan to do and posted the matter for the next hearing on Friday.

# 772 lawyers write to CJI raising concerns on emerging trend to browbeat judiciary

**NEW DELHI** 

A group of 772 lawyers have written a letter to Chief Justice S.A. Bobde to raise concerns on an emerging trend to browbeat and intimidate the judiciary.

"India has witnessed a series of attacks by institutional disruptors against judges who are unwilling to agree with them and toe the line drawn by them. It is unfortunate that when political ends of lawyers are not served by a decision of the court, they vilify the court by making scandalising remarks. The Supreme Court of India as well as the judges are subject to both scurrilous language, malicious attacks and scandalising remarks", said the statement.

On August 14, the Supreme Court held advocate Prashant Bhushan guilty of contempt of court and fixed the date of hearing for his sentencing on August 20. A statement was issued by 'Campaign for Judicial Accountability and Reforms', (CJAR) on August 15, condemning the judgment and further calling upon the Supreme Court, and every judge, to reconsider their decision. CJAR includes a retired judge, Justice PB Sawant, former law minister and senior advocate Shanti Bhushan among others as their patrons.

In the letter to the Chief Justice, the lawyers emphasised that legitimate criticism of both judgements and the functioning of the institution has always existed however when the criticism is calculated and actuated by malice, it is the authority of the court which is undermined. "We urge you to uphold the edifice of the judicial system and protect the third pillar of our democracy from those who peddle falsehood to destroy the institution. We sincerely hope that the Supreme Court of India ensures that such persons are dealt with in an exemplary manner, even if such actions are taken thirteen years later or else such trends will only accelerate and strike a blow to the guardian of the rule of law," read the statement.

### Textile ministry to provide certified seeds to jute farmers, says Irani



#### MoU signed between NSC and JCI for distribution of seeds

NEW DELHI: The Ministry of Textiles has said that it will make available certified jute seeds to farmers through the Jute Corporation of India (JCI) to improve production and productivity of raw jute in the country. The National Seeds Corporation (NSC), a CPSE under the Ministry of Agriculture and Farmers' Welfare, would ensure delivery of the certified seeds to JCI and an MoU was signed between the two on Wednesday for distribution of the certified seeds in 2021-22. Union Minister of Textiles Smriti Irani and Union Minister of Agriculture & Farmers' Welfare Narendra Singh Tomar witnessed the MoU signing through virtual mode, in which the CMDs of JCI and NSC were were also present.

Irani said that in addition to becoming self-reliant in requirement of jute for the domestic market, the next target was to strengthen the export potential of the country in jute and its products. There was immense potential for increasing the use of jute in lining of water bodies, road building and construction of structures to contain landslides in hilly areas, she said.

Tomar stressed on the importance of improving the production and quality of raw jute in the country, and said that providing value addition to the produce will contribute in achieving PM's target of an 'AtmaNirbhar Bharat'.

#### 2 ISIS operatives plead guilty before court

Two persons on Wednesday pleaded guilty before a Delhi court in a case of criminal conspiracy by the ISIS to establish its base in India by recruiting Muslim youths through different social media platforms in order to carry out acts of terrorism in the country.

Accused Abu Anas and Najmul Huda made the submission before the court, which was scheduled to hear arguments on the quantum of punishment for six other accused who had earlier pleaded guilty in the case, their advocate Qausar Khan said.
