Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations"), we hereby inform you that, in order to achieve operational efficiency, synergy, and optimal utilisation of manufacturing resources, the manufacturing operations of the Bengaluru plant situated at No. 260, Bommasandra–Jigani Link Road, Jigani Hobli, Anekal Taluk, Bengaluru – 560105, Karnataka have been shifted to other facility within the same region, in line with the operational requirements and strategic manufacturing plan of the Company.

Accordingly, manufacturing activities at the aforesaid unit have ceased with effect from January 1, 2026, as part of the Company's strategic consolidation of operations.

The transition of operations is not expected to have any adverse impact on the Company's overall production capacity, supply commitments, or financial performance.
